However, we must be vigilant and be prepared to spend time and resources (real money) championing the greatest pension plan in the US.

We've done enough already. Future cost increases related to health care and retirement should be picked up by the state and not state employees.

- Make **climate change** a CAPS priority! Some don't think this is a union issue, but I disagree.
