California State Scientists deserve pay equity now.

We are the rank-and-file State Scientists in Bargaining Unit 10 at the State of California. We have been closely monitoring the bargaining process between our Union, the California Association of Professional Scientists (CAPS) and the State of California. On June 9th, 2022, CAPS received a counter offer from the State that would only give Environmental Scientists an 8% raise over the next 3 years.<sup>1</sup> The counter offer that has been provided to CAPS is simply unacceptable and does not address the pay inequality that state scientists have faced since 2005, let alone inflation.

The Consumer Price Index (CPI) has increased 9.1 percent over the past 12 months ending in June; the largest 12-month increase since December 1981.<sup>2</sup> Inflation is at an all time high and has been chipping away at our wages. **Without at least a 9.1 percent raise this year alone, State Scientists will be taking a pay cut.** CAPS originally proposed a general salary increase (GSI) across all classifications in BU10 tied to the total percent change in the CPI from July 2021 to July 2022. This is necessary to prevent members of BU10 from taking what can be equated to a paycut.

**The State also needs to address the pay inequality that State Scientists have faced since 2005.** Prior to 2005, State Scientists and State Engineers were paid equitably. In 2003, the maximum salary for a Range C Environmental Scientist was \$5,336 while the pay for a Range C Water Resource Control Engineer was \$5,632 . This equated to only a 5.5% difference in pay between engineers and scientists. In 2005, Water Resource Control Engineers received the first of many salary increases. By 2008, the engineer's wages increased to \$7,885 while the scientist's wages fell behind at \$5,711.<sup>3</sup> This equated to a massive pay difference of 38% between engineers and scientists that has persisted to this day. As of 2022, the pay

difference between scientists and engineers still lies at 30% which is a far cry from the 5.5% difference in pay that existed prior to 2005.

Shortly after this pay gap was created, the Department of Personnel Administration (the precursor to CalHR) acknowledged the issue they created by stating “ the State now has severe retention problems in the scientist classes where the duties, responsibilities, and knowledge overlap the engineer classes. State Scientists have been moving into equivalent but higher-paying engineer positions.”<sup>4</sup> State Engineers and Scientists with the State of California perform similar duties and have similar responsibilities yet scientists still receive compensation that is 30% less than their peers. **It is time to fix this pay inequality.**

California Government Code 19826 states that “like salaries shall be paid for comparable duties and responsibilities.”<sup>5</sup> In 2008, CAPS prevailed on a Like Pay for Like Work (LPLW) case. The legal ruling corrected the discrepancy for State scientific supervisors with engineering-equivalent classes. These classes received a one-time pay increase between 18% and 43% in July of 2014.<sup>6</sup> Unfortunately, this ruling did not extend to rank and file employees. The inaction of the State to fix this pay discrepancy has lowered the morale of State Scientists and has given the

impression that the State simply does not value its scientists. **Like work deserves like pay and this should be extended to rank and file employees.**

As of 2022, California has seen its largest budget surplus in state history at 97.5 billion dollars.<sup>7</sup> Scientists deserve to have this pay inequality fixed once and for all with a portion of this historic surplus. If the State of California is unwilling to fix this issue now with the largest surplus in State history, there is little hope it will ever be fixed. Without pay equity, the State of California will find it increasingly difficult to attract and retain a scientific workforce that can afford to work and live in the State.<sup>8</sup>

**We urge the Newsom Administration to close the gap in vertical and horizontal salary differentials during bargaining in 2022.** During a time of historically high budget surplus, this is an opportunity for the State to demonstrate commitment to those who work hard to ensure that California excels in scientific leadership and stewardship of our natural resources for future generations to come.<sup>9</sup>
