CAPS MEMBERS TAKE ACTION FOR EQUITABLE WAGES!

CAPS Bargaining Team (CAPS Team) is fighting for a successor Memorandum of Understanding (MOU) with equitable pay for State Scientists, but they're not fighting alone. Around the state, CAPS members have been learning about the issues and showing their support in a wide variety of ways:

Teach Ins/Rallies: From Chatsworth to Eureka, State Scientists on July 26 participated in a virtual teach in to learn about the bargaining process, then staged workplace rallies to loudly advocate for an MOU that values state scientists.



Regional Rallies: CAPS coordinated its first Value Scientists! Rally on August 16 in Los Angeles (pictured below), followed by a second rally in Oakland on August 23. The third and final event, a march from CalHR headquarters to the State Capitol and a rally on the West Steps was held August 30.



Worksite Tabling: Since May, Contract Action Team (CAT) members have been tabling at worksites throughout California to inform and engage CAPS members. Through July, CAT members tabled at 12 worksites, with four additional worksites scheduled in August. The events allow CAPS members to discuss current contract negotiations and learn how everyone can support the Bargaining Team.

Science Tuesdays/Solidarity Breaks: Every Tuesday, members wear their CAPS shirts and take breaks together (in real life or online) to show their support for our cause. Social media posts are encouraged!

A TIME FOR CHANGE!

A few months ago, I encouraged you to consider running for the CAPS Board of Directors. Since then, several people have stepped up to run for office. Next month we vote, and in November the 2023-25 Board will begin to serve.

Fortunately, that means as times and circumstances change, CAPS is built to change as well. It's that constant, healthy evolution that keeps us steady and strong.

I still have a little while longer before I go, but this is my last election as President, so I want to take this opportunity to urge you to vote when you receive your ballot in October. CAPS leadership should mirror the thinking and priorities of members, and the way that happens is through the ballot. The more members who take the time to vote, the better.

2023-2024 CAPS BOARD OF DIRECTORS ELECTION UPDATE!

Nominating petitions are in, and the candidate lists are set for the 2023-2025 CAPS Board of Directors election.

CAPS Bylaws state, "Any qualified candidate shall be elected by acclamation, without the need for balloting. whenever that candidate is the only qualified candidate whose name will appear on the ballot for that seat." Under that rule. four statewide officers and two District Directors have been elected by acclamation. Two statewide seats and two District Director seats are contested. One District Director position had no candidates. The Board has the authority to fill that seat at a later date.

Only rank-and-file members will receive ballots this year because the Supervisory Director seat for which managerial members vote has just one candidate. Members will receive a link to a ballot at their private email addresses on October 2, 2023. On that same day, postcards will be mailed to members' home addresses with an individualized QR code that, when scanned, will open a ballot. CAPS' third-party vendor, ElectionBuddy, uses software that allows one ballot per person, so members may use just one method to vote. Balloting closes on October 17, 2023, at 5 p.m. (PDT), and results will be released as soon as practicable.
